Nomination Entry Form

The Mehdi Heydari CCM of the Year Award program is designed to recognize and commend the culture of certification within the construction management industry. Nominators must complete all areas of this form prior to submission of the entry. Entries are being accepted via email or mail. The deadline for submissions is June 30, 2017. There is no entry fee required and self-nominations are accepted. All nominations will be reviewed by the CMCI Nominations Committee for a final decision by the end of the third quarter of the calendar year.

Select from the possible criteria (minimum of one) that you wish the candidate to be evaluated:

- Advocacy and representation of the CCM
- Contribution to the Construction Management industry
- Breadth of program(s) or project(s)
- Creative solutions or innovations
- Excellence in customer service
- Involvement in the community
- Professional reputation

In PDF format; not to exceed two (2) pages:

- Provide a statement discussing the individual and why they deserve to receive recognition. Also, include a detailed description of the how the candidate met the categories selected from above.

In PDF format; not to exceed three (3) pages:

- Additional supporting documentation or recommendations, if desired.
