 - d. Managing the field change order process to ensure contract change requests are well documented and adhere to SOX.
 - e. Operational controls. Enforce invoicing procedure amongst the Construction Supervisors.
 1. Coordinates with PPL Groups and External Organizations for, but not limited to:
 - a. Environmental permitting and compliance
 - b. Outage planning and coordination efforts
 - c. Vegetation Management impacts on construction
 - d. Foreign utility moves
 - e. PA One Call
